This policy sets out how we seek to protect personal data and ensure that our members and officers understand the rules governing our use of personal data.

### Business purposes

We will share aggregate information on our membership without any identifying individual data, based on this data, with interested parties.</p> <p>We will retain this data so long as you are a member of the CLT.</p>

We share your name and email address with Mailchimp. Surveys	<p>Where we undertake housing needs surveys we may collect detailed personal data on households, including data on each individual in the household and your financial circumstances. The information provided will be used by the CLT to provide information for a Housing Needs Survey Report, and no data will be shared or published which can identify any individual.</p> <p>We may also undertake other surveys.</p> <p>More detail on the information to be collected, the purposes, how we will use the data, and with whom it will be shared, will be set out on the survey.</p>

### Our procedures

#### Fair and lawful processing

We will process personal data fairly and lawfully in accordance with individuals' rights. This generally means that we should not process personal data unless the individual whose details we are processing has consented to this happening.

#### Accuracy

We will ensure that any personal data we process is accurate, adequate, relevant and not excessive, given the purpose for which it was obtained, and that it is not held for longer than is necessary for the business purpose set out above. We will not process personal data obtained for one purpose for any unconnected purpose unless the individual has agreed to this or would otherwise reasonably expect this.

Individuals may ask that we correct inaccurate personal data relating to them. If you believe that information is inaccurate you should record the fact that the accuracy of the information is disputed and inform the Data Protection Officer.

### The Data Protection Officer's responsibilities

- Keeping the board updated about data protection responsibilities, risks and issues
- Reviewing all data protection procedures and policies on a regular basis
- Ensuring data protection statements are attached to all forms used to collect personal data, and to all marketing materials
- Addressing any data protection queries from members, supporters and other stakeholders
- Ensuring all systems, services, software and equipment meet acceptable security standards
- Arranging data protection training and advice for all officers and staff
- Checking and approving with third parties that handle the company's data any contracts or agreements regarding data processing

### The responsibilities of other officers, staff and volunteers (data processors)

- Only to process personal data for the purposes set out in this policy
- To store electronic data in secure systems, and paper records in a secure place
- To generally avoid storing personal data on mobile devices such as laptops, phones and memory sticks, and where it is necessary to then use password protection
- To report any concerns or breaches to the Data Protection Officer immediately, and to take remedial steps if necessary

### Subject access requests

A data subject may, subject to certain exceptions, request access to information held about them. Please contact the Data Protection Officer if you would like to correct or request information that we hold about you. There are also restrictions on the information to which you are entitled under applicable law.

### Data portability

Upon request, a data subject should have the right to receive a copy of their data in a structured format. These requests should be processed within one month, provided there is no undue burden and it does not compromise the privacy of other individuals. A data subject may also request that their data is transferred directly to another system. This must be done for free. Please contact the Data Protection Officer with any such requests.

### Right to be forgotten

A data subject may request that any information held on them is deleted or removed, and any third parties who process or use that data must also comply with the request. An erasure request

can only be refused if an exemption applies. Please contact the Data Protection Officer with any such requests.

### International data transfers

Other than Mailchimp, no data will be transferred outside of the EEA without the explicit consent of the data subject.
